March Madness Trial Membership 2010

Terms of the offer include:

- **Effective February 20, 2010 join on or before April 1, 2010.**
- **Ski for the balance of the 2010 season Free!**
- For a \$1,000 Trial Member Payment you have free skiing for the balance of the ski season, no extra fees, and no payments, **plus you will receive a \$250 credit to be applied to any eight or nine week instructional or racing program during the 2010/2011 season only.**
- Full membership privileges for the 2010/11 season except voting rights and reciprocal privileges
- Full use of all facilities and inclusion in all member programs and social events (space permitting).
- Your \$1,000 payment becomes your trial membership fee for the 2010/11 season.
- \$1,050 (\$1,000 plus applicable G.S.T.) is due on application and is non-refundable.
- Trial Members will pay full annual dues per Mansfield policies by September 1st, 2010 to ski as Introductory Members for the 2010/11 season. The Capital Contribution will be waived for the 2010/2011 season.
- The \$1,000 payment is deductible from the initiation fee payment upon joining as a full member of the Club.
- Trial Members must elect on or before March 30th, 2011 if they plan to become full members and can pay the remaining balance either upon application for full membership or over three years. The remaining balance is \$4,000 (plus tax) if making payment in full; if you choose the three year payment plan the remaining balance is \$4,500 (plus tax).
- This offer is only good and valid to the end of the 2010/11 season and can not be renewed.

Payment in the amount of \$1,050.00 (\$1,000.00 initiation fee and \$50.00 GST) is included with this application.

- Trial Members have full membership privileges except voting rights and reciprocal privileges.
- Trial Members have use of all facilities and inclusion in all programs and social events (space permitting).
- This offer includes ski free effective February 20, 2010 for the balance of the 2010 season.
- This offer includes a credit in the amount of \$250 toward any eight or nine week instructional or racing program for the 2010/2011 season only; if joining February 20, 2010 to April 1, 2010.
- Trial Members will pay full annual dues per Mansfield policies by September 1st, 2010 to ski as Introductory Members for the 2010/11 season, with the exception of the Capital Contribution.
- The initiation fee of \$1,000 is non-refundable and can be applied against the full membership fee.
- Trial Members must elect on or before March 30th, 2011 to become full members.
- Upon approval of application for full membership in Mansfield Ski Club the second or final installment of the initiation fee is due. The amount will depend on the payment plan chosen (see below).
